Chair's report



Welcome to our 2009 Annual Report, launched at the Deaf Parenting Conference in London on 7th July 2010: Are We Equal? in accessing to health, social services and children's education.

It is amazing how times flies so quickly in the period of 2009 which has been a busiest year for all of us including 12 awards in last 18months.

The start of 2009 saw Deaf Parenting UK receiving requests via our helpline of which huge proportion of 57% were for parenting supports to deaf parents/ families. We also received 22% request from parents and

professionals to provide legal advice/ representation where Deaf parents were at the crisis stage. Those two highest figures is a staggering huge part of our work aswell as DPUK helpline which is manned by our DPUK coordinator working 7 hours a week.

We have come so far since we started in April 2001 as a small project into a small national organisation with two part-time staff (7 hours a week each). Despite the difficult economic climates that comes our way, we have continue to operate as social enterprise and kept the organisation going, to meet the needs of Deaf parents and professionals working with them.

Looking at our history of supporting Deaf parents and professionals, we have identified patterns over the years and previous conferences 2008 looked at Enabling confidence, empowering and supporting Deaf parents which became Deaf Parenting UK's motto in delivering our services. Conference 2009 looked at Education, Education, Education, challenging the Government as to the importance of our children's education but access for Deaf parents were limited. This brings to our next conference 2010: Are We Equal? in accessing to health, social services and our children's education. Our organisation will be 10years old next year in 2011 but how far have we come in improving access for Deaf parents? This year conference would be interesting and challenging for all of us especially with the new changes in Government of Con-Lib coalition and the huge budget cuts that are affecting all services including health, social services and children's education. Will they be engaging well with us and consider the needs of Deaf parents or will they be reviewing all of their policies and cut us out of the loop. There are lots of news in the media about the huge cuts would in turns affect all disability and families services across the country including tax credit, welfare reform. It is a worrying time for all of us.

With the hard times ahead of us, we need to look at the future, drawing on the strength we all have and to support one another and to give our best shot at the Conference 2010 as well as engaging with the Government. This is not the time to give up and we need to unite more and fight harder. Our hard work will continue to focus on reaching out more Deaf parents and professionals aswell as providing services to meet their needs.

We hope to mark our 10 years anniversary in 2011 with a difference by celebrating our achievements aswell as presenting awards to those deserving individuals / organisations who made differences to the lives of Deaf parents. We need your support to make it happen. Watch this space.

Finally, our tremendous thanks to our two part-time staff, Nicole Campbell and Asif Iqbal, for all their incredibly hard work and commitment in delivering services, exceeding above their duty in making things happened for Deaf Parents aswell the committed support of our Trustees and stakeholders.

Vision and Mission Statement

Our vision is to be the first part of all for Deaf Parents with children with local branches and affiliated services throughout the UK by 2013

Deaf Parenting UK is the first ever national charity organisation to be led and managed by Deaf parents for Deaf parents with deaf, hearing and disabled children, representing the needs of Deaf parents in the UK, of whom are sign language users. According to statistics, 90% of Deaf people, as parents, have hearing children.

Deaf Parenting UK strives for all Deaf parents and their children to participate in society as equal as any other parents, to be able to make informed choices and to exercise control over their lives as well as to promote their children's well-being.

In order to meet our mission and vision statement, we have outlined our objectives and activities of how we can enable, empower and support Deaf parents as follow:

Objectives & Activities

Our Objectives are:

- a) To enable confidence, empowering and supporting Deaf parents/parents through providing:
 - Deaf Parenting Skills Courses
 - 1:1 Support on Parenting Skills
 - Befriending services
 - Membership services
- b) To identify the gaps in services for Deaf Parents in the UK and make recommendations through:
 - Addressing issues where service providers are accountable.
 - Media & Promotional events
 - Advice/ email / text helpline
 - Research / influencing policies
- c) To work with public services, including Health, Social Services, Deaf & mainstream parenting organisations and improve access to information and services for Deaf Parents through:
 - Encouraging services providers to be deaf aware.
 - Presentations, consultations and meetings
 - Promoting DPUK as a partner to deliver services

Why the need for Deaf Parenting UK?

Deaf Parenting UK was established by Sabina Iqbal as a project in 2001. The project became an independent organisation in 2004, following her research done on gaps in services for Deaf parents within the UK. Sabina's research, revealed a scenario of risks to families of Deaf parents – services demonstrating the lack of awareness and appropriate consideration of the needs of Deaf parents.

Because of varying hearing-led communication issues within the home and at school, Deaf children often lack reasonably adequate access to basic information in the area of personal, social and health, such as growing up, sex education, pregnancy and parenting. The reality of such backgrounds and statistics expose these facts:

- 90% of Deaf children are born to hearing parents. As well as mainstream support and information, which is available to parents in general, parents of deaf children have limited access to information, resources and support via Social Services and Deaf children's organisations. There is information on parenting (for hearing parents) of deaf, hearing and disabled children which is readily available in print, Video/DVD material and Parenting Classes etc.
- When those Deaf children grow up into adults and become Deaf parents, what is appropriate for them to get resources, information and support in accessible formats, is scarce or fragmented locally and nationally. Therefore the lack of such access creates an acute issue when Deaf Adults have a 90% chance of having hearing children.

The following is common in Deaf parents' daily lives, as services offered to Deaf parents are sometimes non-existent, very limited or patchy as compared to those available to hearing parents:

Deaf parents are unable to easily access mainstream information - parenting skills classes, midwives or health visitors. Deaf parents find it difficult to access or adequately participate in their children's school life due to inability of staff to appropriately communicate in sign language or lack of Deaf awareness.

Request for support:

Professionals from statutory services have contacted **Deaf Parenting UK** with requests to provide support. Individuals and organisations have been inspired by the impact of the pilot work in London.

- Our research (2001, 2008) shows that Deaf parents suffer from poor communication within their own extended families, fail to engage effectively with other parents and become very isolated.
- Deaf parents' needs are primarily linguistic and cultural and they fail to receive the support they need and so continue to lack in confidence and remain confused and feeling vulnerable.
- Frustration and isolation can be expressed in chronic anxiety or depression, sometimes tipping over into psychosis.

At DPUK's recent National Conference, June 2009 and previous conference, October 2008, delegates reinforced the need for its services to be delivered locally and impartially.

Deaf Parenting UK continues to work tirelessly to campaign for equality for Deaf parents. To date, they are 'voiceless members' of our society, whose needs have not been adequately met by mainstream resources as demonstrated above. Despite current Equality legislation, DDA and the Human Rights Act many of those parents are unable to fully enjoy their own family lives or effectively participate within their parental roles to decide their children's futures rationally.

Deaf Parenting Support:

Deaf Parents and professionals have contacted Deaf Parenting UK for support and as a result, we offered the following:

1) Parenting Skills Course Workshops

Pacesetters Project based in Bristol, working in partnership with the local PCT on community issues on health/mental health of deaf people. Pacesetters received funding for DPUK to run two parenting skills workshops in Bristol, which ran from October 2008 – January 2009.

The workshops were hailed as a success and have been proved to be beneficial for the Deaf parents. Pacesetters have asked DPUK to run a 2nd series of parenting skills workshops.

Pacesetters and NHS Bristol have commissioned DPUK to run 2 years project of parenting support workshops in Bristol to take place June 2010- Dec 2011.

2) 1:1 Parenting support

We offer 1:1 parenting support for Deaf parents who were often in crisis stage and need immediate support. It is often the result of the social services/ health referrals that commissioned Deaf Parenting UK to provide 1:1 parenting support.

Furthermore, most Deaf parents benefited from 1:1 parenting support especially if there is no parenting skills course workshop available near them or if their needs are better met on 1:1 basis eg: Deaf with learning disability/ mental health support needs.

This is a snapshot of 1:1 parenting support, commissioned by the following council/ referrers that we carried out throughout 2009.

Facts/Figures:

Since 2005 to date, with 1 part time staff (Coordinator) and one freelance trainer, we have successfully supported Deaf parents by the delivery of:

- Deaf Parenting Skill Courses (average 12 weeks per course) including Pre-natal for pregnant parents to be; parents with children aged 0-9 and parents with teen aged 9-18yrs) to directly support 120 parents (12 courses, 2-3 courses per year), an increase of 47% from last year (65 parents)
- 1:1 Parenting Support: 220 sessions, supporting 27 parents/ family (average 8-12 sessions per family), an increase of 37% from last year (17 parents)

DPUK Forum via Deaf Parenting UK website aswell as email groups for Deaf parents which offers opportunity for Deaf parents to raise comments / concerns or suggestion to share with other Deaf parents. This has been popular with average viewing of 800-1300 per message listed since its launch in 2007.







The amount of referrals, type of referrers and demographic of referrals/ enquiries can be demonstrated by our charts below:

Referrals / Enquiries received for the period of Jan 2009 to Dec 2009:







The above enquiries are manned by our DPUK coordinator working 7 hours a week with support from Trustees.

All replies to emails are usually dealt within few days and sometimes within a week depending on the coordinator's availability. Those of complex natures are passed onto Trustees to reply / provide suitable advice and this can take longer. Coordinator have exceeded beyond the 7 hours a week remit to keep the service afloat.

Challenges:

In each work we do with Deaf parents during group sessions or 1:1 basis, we appreciate the challenges that they faces as Deaf parents even though those may be typical in the parenting roles including the battles that they struggles with e.g.:

- Deaf Parent unsure of how to support her child who has been raped / sexually assaulted.
- Deaf parent found it difficult to deal with teenager rebelling at school as a result of bullying because her parents are Deaf.
- Deaf parent struggle to understand and how to support their teenager who dropped out of school and is also pregnant.
- Deaf parent was suspected to have mental health needs ('OCD' and panic attacks, together with depressive disorder) which impact on their child being confused due to lack of parental control between both Deaf parents.
- Deaf parent whose wife's language is not English and is not sign language user and their children used as 'interpreters' to bridge communication gaps.
- Deaf parent whose two young children were removed from her care, the court case pending on adoption proceedings.
- Deaf parent with a child diagnosed with ADHD.

The above examples proved to be tremendous challenges for Deaf Trainers to work with those parents in group sessions or in 1:1 session. The amount of work from the programme was basic to reflect their needs to absorb the information and repetitions. Given that the workshop / sessions ranged from 8-12 sessions (weekly), it is important to highlight that parents would have had difficulty adjusting to new skills learnt and that we are giving them the tools to understand and improve their parenting skills with better outcomes in their children/family unit.

Parents had to learn how to regain control by dealing with their feelings in order to support their children. The parents also needed to learn how to be assertive and set discipline/boundaries with their children in order to increase the ability to deal with children's challenging behaviour.

Furthermore, from DPUK's observation and discussion with parents, it appears that lack of support and access to services had an adverse effect on their health and lifestyle, which has led to them facing really challenges in parenting their children appropriately.

Positive outcomes:

Many parents reported the immediate benefits of mutual support of other Deaf parents in group sessions and learning from one another. They were fully supported in their environment where all Deaf parents and DPUK trainers are BSL users.

Also from the 1:1 parenting support sessions, many parents reported seeing the instant changes in the family unit e.g.:

- Hopes and fears of Deaf parents were overcome and dealt with in a supportive manner with the support of DPUK trainer.
- Establishing routines for Deaf parents to deal with their children eg: bedtime and toileting routines identified in session 1 and accomplished in session 5/6.

 Identified appropriate play and stimulation appropriate to children's age which in turned improve the relationship with parents and child.

Unmet needs:

We have a waiting list of parents in needs of 1:1 parenting support, advocacy support and parenting workshops (41%) which we are unable to meet for the following reasons:

- Lack of funding for parenting skill courses from individual local authority/PCT. This also includes requests to us for funding assistance.
- Lack of awareness on numbers of Deaf parents in local area to needed to maximise the group work sessions. It is mostly the case of individual Deaf parents at crisis stages that resulted in referral to Deaf Parenting UK for parenting support.
- Lack of qualified Deaf trainers to meet the demand for 1:1 parenting support and parenting skill courses as we only have three qualified trainers which are dispersed, one in Scotland, one in Bristol and one in London. All of them have their own full time jobs and work with DPUK on ad-hoc basis.
- DPUK is a social enterprise organisation so for every service we provide, there is a charge to organisations (e.g.: local authorities/ PCT) but not to parents as it is our philosophy to ensure Deaf parents access to our services free in the same way as hearing parents access to mainstream parenting services. This in turn, have consequence on those organisations especially local authorities/ PCT who have limited funding/ grant opportunities and only commissioned Deaf Parenting UK on adhoc basis (e.g.: social services working with individual Deaf parents / families).

Support Groups & Family Fun events:

Deaf Parenting Support Groups:

Deaf Parenting UK believe in enabling network and peer support among Deaf parents locally/ regionally and work closely with partners including local Deaf parents support groups, Deaf Centres, Family Centres and Deaf parents themselves who have their own support groups.

It is vital for Deaf parents to give and receive support from other Deaf parents and learn from each other. Social Isolation is a major barrier for many Deaf parents especially if their friends/families are far away, mean limited support network to support them in the challenging times or even to support Deaf parents when they needs someone to talk to. Deaf Parents support groups is a lifeline for many Deaf parents who were unable to access to mainstream parenting support group.

Deaf Parenting UK recognises that in some areas, there are Deaf Parents Groups running but in some areas, there are gaps. Deaf Parenting UK encourages all Deaf parents support groups to be set up locally, regionally and nationally and also all Deaf Parents groups to register their details FREE onto Deaf Parenting UK website so that Deaf parents can browse to find out where are their nearest support groups and details of when and how often to meet. Their events can also be added onto Deaf Parenting UK's Event Calendar which can be viewed on the website www.deafparent.org.uk and click on Event Calendar.

For those reasons of gaps in provision and lack of support for Deaf parents to reduce their social isolations, Deaf Parenting UK have organised a series of Family Fun days in London funded by Children in Needs.

Children In Need Fund Update

DPUK's Children & Families Project including some volunteers funded by Children in Need grant has had a fun year. It has enabled the project to run a vibrant programme of activities and meetings aimed at reducing isolation and working to strengthen families – this offered positive life experience for children of Deaf parents also known as CODA (Children of Deaf Adults).

Family Fun Days – 640 parents/families benefited from the 12months project (Sept 2008-Sept 2009)

DPUK Conference 2009:



National Association of Head Teachers (NAHT), Department of Children, School and Families (DCSF), Daycare Trust, Sign for Success, Deafness Cognition and Language (DCAL) Research Centre and Equality and Human Right Commission (EHRC) as well as two local Deaf parents gave presentations on Education, enabling Deaf Parents to access to their children's education of which many experienced numerous of barriers.

Deaf Parenting Conference 2009 was held on Friday 12 June 2009 in London and attended by 200 people, mostly Deaf Parents aswell as professionals / service providers working with Deaf parents. The theme of the conference on Education touched the core issues shared by many Deaf parents and bringing them from across UK aswell Deaf parents from Italy, Belgium, Cyprus and Greece who challenged the Government and representatives from National Association of Head Teachers (NAHT), Department of Children, School and Families (DCSF), Daycare Trust on the needs of Deaf parents in accessing their children's education without barriers.

Julia Gault, Head of Families Unit, Families Engagement Division, Department Children, Schools and Families (DCSF): "The conference provided an important opportunity for deaf parents to bring their issues directly to those like myself working on the future direction of national policy. my work towards the Government 2020 Goal that all parents will be satisfied with the information and support they receive."

Deaf Parenting UK have been organising Deaf Parenting Annual conferences aswell as some forum / meetings in the last few years (2005 to date) which has been attended by 450 Deaf parents and 300 professionals. There is a steady growth from when we first started in 2005 at the launch of DPUK logo with 50 parents and 20 professionals and our biggest success was the Conference 2009 which attracted 200 Deaf parents and professionals of which 65% are Deaf parents and 35% professionals.

Deaf Parenting UK strives to involve Deaf parents and professionals, on thematic issues affecting Deaf parents, enabling them:

- have a platform in sharing their experiences and what they want to see improved,
- working with service providers to identify gaps in services,
- removing barriers in accessing to services,
- influencing Government on policies concerning Deaf parents / families.

The Baby Shows 2009:

Deaf Parenting UK launched its first working partnership with the Baby show at Earls Court on 17 October 2008. Since then, Deaf Parenting UK has been working closely with The Baby Show to ensure Deaf Parents and Deaf Expectant Parents were fully inclusive in the same way as any other parents accessing to The Baby Shows. Exhibitors were able to take advantage of the unique service to communicate with Deaf parents as new customers.

Fact/Figures:

Deaf Parenting UK have been working closely with The Baby Show and as partnership work, we had DPUK stand and provided BSL interpreters for the three days show, twice a year.

We are delighted that since 2008 when our partnership was formed, we have succeeded in reaching out 120 Deaf parents who came to the Baby Show. Also the partnership enabled us to promote our work throughout the Baby Shows which were a great success.

Raising profile & Partnerships:

The year 2009 was the busiest year of *Deaf Parenting UK* in being commended. There was a combination of awards, media interviews, increased public support for Deaf Parenting UK, and recognition by the Political Parties including David Cameron and Nick Clegg; appointments of new ambassadors including Annette Brookes MP, Carissa Williams, Graham Taylor and Vanessa Whitehouse; and working with Department for Children, Schools and Families in their 'Parental Engagement Project', consulting with Deaf parents for their views in accessing to schools.

We have been busy raising profile of Deaf Parenting UK by giving interviews with various magazines including Disability Now; front cover of National Childbirth Trust's NewGen (Spring 2009), Midwives Journal; DPPi (Disability, Pregnancy & Parenthood International); NSPCC's 'Your Family Magazine'; and Emel (Muslim lifestyle) Magazine, The Times Newspaper as well as 'Wicked', first BSL TV programme by BSL Broadcasting Trust.

DPUK's first breakthrough in working with the national newspaper Daily Mirror as Deaf Parenting UK has been included in the advertisement section in a special edition of the Mother and Baby Feature on 22nd March 2009. Our logo reached 2.6 million people nationally.

1) West Midland Government Office, Birmingham, January 2009

Deaf Parenting UK was invited by West Midland Government Office to give a speech at their `Think Family' conference in Birmingham in January 2009. The aim of the conference was for the service providers to think how they would provide support and ensure that their services meets the needs of various 'hard to reach' families including Deaf parents in the Midlands area.

2) Signed Stories Launch, London Weekend Television, January 2009

Deaf Parenting UK was invited to give a speech of support at the launch of Signed Stories at the LWT (London Weekend Television). Signed Stories is a website where all stories are signed into BSL with audio and subtitles. Deaf Parenting UK gave their support as it enables Deaf Parents and their children (both deaf and hearing) to access those stories as well as improving the quality time together as family.

3) Bristol Deaf Studies Trust – HDM Talk: 29th April 2009

DPUK Hosted a presentation on "How you can understand your child/teenager better" at the Bristol Deaf Centre. The aim of the presentation was to provide some information to Deaf people in BSL friendly format that relates to their parenting experience – in order to recruit parents for the 2nd series of parenting workshops.

4) Leicester Action Deafness Festival: 9th May 2009

As part of Deaf Awareness Week 2009, Action Deafness held a Deaf Festival to celebrate deafness and provide advice and information. A variety of organisations set up exhibitions, and workshops throughout the event. Deaf Parenting UK set up an information stall, an opportunity for Deaf people to obtain information about DPUK Services.

5) Deaf Parenting UK is delighted to show their support to 'The National Family Week', May 2009

Deaf Parenting UK, as the first ever charity and a unique organisation focusing on enabling, empowering and supporting Deaf parents/parents-to-be, were delighted to hear that National

Family Week is taking place to recognise and celebrate the diversity of families across the country. Deaf Parenting UK wish National Family Week every success.

6) Deaf Muslim UK, Regent Park Mosque, London, 16th May 2009

Deaf Muslim UK invited Chair of Deaf Parenting UK to give presentation about Deaf Parenting UK and the work it does. Many had the opportunity to stand up and share their experiences, putting forward questions to Sabina about their parenting experiences and how Deaf Parenting UK can offer advice and support.

7) Deaf Parenting Conference 2009 in British Sign Language, supported by Sign tube. 9) Oak Lodge School Work Related Learning Day – Thursday 18th June 2009

Oak Lodge School hosted their Work Related Learning Day for Year 11 Pupils and invited Nicole Campbell, DPUK Coordinator to give a talk about her path to employment at DPUK. The set up of the Work Related Learning Day was those enable the students to start thinking about their future as they begin their transition to adulthood at important time in their lives.

The event provided an opportunity for Deaf parents and carers to get together and share their experiences. Deaf Parenting UK, along with other organisations such as Maldon Young Carers, and Chelmsford Children's Service set up own stalls and were on hand offering valuable information and advice.

11) Deaf Parenting UK launched mutual working partnership with The Science Museum, 5 September 2009

There were lots of Deaf families interested in the Science Museum BSL Events. The fun free family events were run on the first Saturday of every month, with provision of British Sign Language Interpreters. The weekend of 5th September was attended by the record number of Deaf families at this event, which was great news as would like to encourage Deaf Families to experience the exciting range of activities and DPUK events that is available and geared for deaf parents and their children.

12) Deaf Parenting UK working with DCSF and other organisations on Parental Engagement September 2009 to date:

As result of our recent conference last year on Education, Education, Deaf Parenting UK was invited to be involved in the Department of Children, School & Families (DCSF)'s Advisory Group, consulting on the Children's Plan. The Advisory Group is looking at ways of supporting parents better and enabling parents to have full access to their children's learning and Deaf Parenting UK is representing the views of Deaf parents.

13) Deaf World 2009: New Beginnings Conference in Southampton on 1st October 2009Deaf Parenting UK was invited by Hampshire Deaf Association to speak about Deaf Parenting UK's work with Deaf Parents and their children/ families at their Deaf World 2009: New Beginnings Conference in Southampton on 1st October 2009.

14) International Planned Parenthood Federation (IPPF) 24th November 2009.

Deaf Parenting UK continued to raise the issues of Deaf parenting in UK and was delighted to work with partners local, nationally and internationally and support one-another to reach out as many Deaf parents as possible. Sabina of Deaf Parenting UK was delighted to meet Dr. Jacqueline Sharpe (IPPF, President), Professor Mahmoud Fathalla, (UN award winner and international campaigner for safe motherhood and human rights), Christine McCafferty MP (Chair of all Party Parliamentary Group on Population, Development and Reproductive Health) and Gill Greer (Director of IPPF), to explain Deaf Parenting UK's work and how vital it is for Deaf people especially in developing countries to have access to IPPF's information and resources as they miss out on so much due to the communication barriers facing deaf parents.

15) Deaffest Film & TV Gala Awards, Wolverhampton, 28 November 2009

The Deaffest Film & TV Gala Awards was held on Sat 28 November at the Light House, Wolverhampton. It was the red carpet event of the year when the awards for Best TV Programme, Best Experimental Film, Best Factual Film and Best Drama were presented. Sabina Iqbal Chair/Founder of Deaf Parenting UK was the host of the evening and used this opportunity to network and raised the profile of Deaf Parenting UK.

16) RADAR People of the Year Awards 2009, Battersea 30 November 2009

Sabina Iqbal, Chair was presented a Lifetime Achievement Award from the prestigious RADAR People of the Year Awards 2009 at Battersea Evolution.

The People of the Year Awards is the only event in Europe that recognises and honours individuals and organisations that have made a significant contribution towards the furtherance of human rights for disabled people in the UK.

The Awards ceremony was attended by over 500 VIPs and guests from the worlds of corporate disability and public sector, business, government, arts & media, politics and disabled people.

17) Ummah Channel, December 2009

Sabina Iqbal, Chair/Founder Deaf Parenting UK was interviewed by Ummah Channel's `Successful Muslim' - a one hour programme slot. It is a light look into the life of Successful Muslims. The interview was similar to Jonathan Ross's style.

Ummah Channel (Ummah means `Community' in Arabic), was broadcast to over 165 countries around the world, 24 hours a day 7 days a week. In the 'Successful Muslim' programme, Sabina was an inspiration, a positive role model, explaining about her life, her journey and her achievements especially with Deaf Parenting UK and concluded with a powerful message to parents of Deaf children and Deaf parents.

The `Successful Muslim' programme was aired on Ummah Channel in December 2009 on Sky channel no. 828, with repeated shows during the day/ evening for a month.

18) Deaf Parenting UK endorsed Child's Play Signing Cards:

Deaf Parenting UK have worked in partnership with www.childs-play.com company, advising them on the BSL usage for their child's play signing cards and encouraging them to market it to Deaf parents as well as Deaf children.

Beth Cox, Educational Sales and Liaison Coordinator said: "It was great to meet Deaf Parenting UK for the first time at the Baby Show 2008. Although Child's Play aim to develop resources that are suitable for ALL children, we are particularly aware of the lack of books that include British Sign Language so are actively expanding our range in this area. I hope that we can work together to promote our existing sign language resources to Deaf parents and work together to create more valuable resources in the future."

19) DPUK NETWORK: National Equality Partnership Consultation

The National Equality Partnership (NEP) is a project that supports the third sector charities to challenge inequality and promote equality and human rights. It is a three year project (2008-11) funded by Capacity builders under the Improving Support Programme.

Their national programme covers the whole of England and its remit is to deliver services to sector support providers such as umbrella bodies and infrastructure organisations to help improve how third sectors tackle equality, diversity and human rights.

The project is focused on the needs and it has established a reference group. DPUK have enlisted and now have the opportunity to network with people from other organisations facing similar challenges and contribute to a programme that has the potential to deliver changes for groups working on equality, disability and human rights.

Fact/Figures:

Deaf Parenting UK have been working closely with partners outline above to raise the profile of Deaf Parenting UK and our work, thus reaching out as many Deaf parents and professionals as possible across the UK.

This work meets our aims/objectives of working with partners to:

- Encouraging services them to be deaf aware.
- Presentations, consultations and meetings.
- Promoting DPUK as a partner to deliver services.

As well as working with Deaf parents to:

- Be aware of our services and encourage membership to be kept informed via newsletters/ network and DPUK website.
- Enable confidence, empowering and supporting Deaf parents via our services.

We have received so many requests to do outreach work but due to insufficient funding, we only manage to achieve the above as much as we could within our limited resource of 2 part-time staff (both 7 hours a week).

It is essential for Deaf Parenting UK to continue working with those partners and enabling them to be more accountable and promote DPUK as partner to deliver services.

Awards 2009:

Deaf Parenting UK is pleased to be in receipt of several awards in 2009 in recognition of our work. This has highlighted the importance of our work and the needs for us to continue in reaching out and providing services to Deaf parents and professionals within UK as well as a leading example of good practice worldwide.

Muslim Women Power list 2009:

Many Congratulations to Sabina, the Chair of Deaf Parenting UK, one of the 13 Muslim women who have been named on the Muslim Women Power List 2009, Equality and Human Rights Commission. The Muslim Women Power List commends the achievements of Muslim women in business, the arts, media, voluntary and public sectors. It will raise awareness of their social and economic contribution to British working.

Deaf Parenting UK was 'High Commended' UK in the Research, Advice & Support category.

The charity's result for the year ended 31 December 2008 was a deficit of £3,289 (2008-surplus £890).

Receipts were £24,152 and outgoings £27,441. The cash funds balance at 31 December 2009 is £12,169. The Children in Need Project grant have all been spent and all the balace is in unrestricted fund.

Structure, Governance and Management

75% of the Trustees must be Deaf parents (including foster/adopter) or Deaf parents to be. At the moment, 100% of our Trustees are Deaf parents themselves with children of all ages which brings a rich diversity of experiences to Deaf Parenting UK.

Trustees meet 4 times a year as well as keeping in touch via Deaf Parenting UK Trustee email group. Trustees are appointed or reappointed annually at the Annual General Meeting held in July.

We have reviewed and updated the Deaf Parenting UK's constitution (originally adopted December 2004 and revised in December 2006) and Safeguarding Children policy to reflect the current climate.

All our staff and volunteers of Deaf Parenting UK have been CRB checked in line with our Safeguarding procedure.

DPUK Services:

Deaf Parenting UK has a vast range of services which includes as follow:

- 1. Deaf Parenting Skill Course (DPSC) for:
