# DPUK MAILSHOT Your experiences, your views, your topics....



## 'I smack and I'm

**Proud'** programme was shown on ITV1, 9pm Thursday 21<sup>st</sup> September 2006. The programme was about parents being proud of smacking their children.

I watched the programme and disagreed with their views on smacking.

Children today, need to know from right from wrong and have respect for their elders and the society that we live in.

The truth is Parenting is difficult, this is one of the controversial subjects we talk about all the time – we call each other right or wrong until we are blue in the face!

The fact is children do need rules, discipline and clear boundaries but there are countless ways of doing this. Parents need to be creative and find ways of working with children to ensure good behaviour, not compliance through fear.

# Do you think parents should be allowed to smack their children?

I believe smacking should be used only as a definite last resort. Parents need to show children their boundaries, as we know the saying goes... boundaries and disciplines make children feel loved and secured.

Which do you REALLY think is more harming to a child?

Failing to outline a serious boundary because the child has not taken a verbal warning, material punishment seriously? OR

A light smack - that will actually work by "shock" rather than true physical harm?

If it comes to the point that my child stops responding to other disciplines, then I will resort to smacking and for the record, I **WON"T** be "proud" - but I will do it Names have been withheld on request.

# Information on finding the right childcare...

We know that finding suitable childcare for your children is a big decision, and one that depends on your family's personal needs and circumstances.

I have 2 children who both now attend school full time, but as toddlers they were cared for by a childminder.

Finding suitable childcare was difficult, but thanks to the support of my mother who found lots of information from my local council's Children's Information Service.

The only problem was that the leaflets were not BSL friendly and I know that not all deaf parents would be able to make informed decision through lack of understanding. there Also was no information about where we can book an interpreter to help with communication needs and who would cover the costs etc.

With my mother's support I found a good childminder and my children have adapted well with this childminder, it was also good for them to interact with other children as well.

I did have one small problem with the childminder when she contacted my mother for some clarification. As a parent I felt that she should have contacted me directly. Her response was that it was quicker to contact my mother and I put her straight that she should contact me first and foremost through typetalk or email etc

Perhaps there is a need for childminders to attend Deaf Awareness Training so that they are fully aware of deaf people's needs. It may be a good idea to contact the National Childminder Association and influence them to take up training on Deaf Awareness for their staff/members etc.

Tax Credits...what is it?

From April 2003 the Government introduced the Working Tax Credit and Child Tax Credits.

Tax credits are payments from the government to help with everyday costs. If you're responsible for at least one child or young person who normally lives with you, you may be eligible for Child Tax Credit. If you work, but earn low wages, you may be eligible for Working Tax Credit.

You cannot receive Working Tax Credit if you are not working.

Are you receiving Tax Credits? Check to see if you qualify for Child Tax Credit / Working Tax Credit. For more information about tax credits, check out the websites:

# **DPUK Announcement** Sharing your news....

Did you know...

The new law on child car restraints came into force on Monday 18<sup>th</sup> September 2006.

Children aged under 12 and measure less than 135cm (4' 5") must use the right baby/child car seat, booster cushion suitable for their weight when travelling in cars, vans and goods vehicles.



- Check any labels for suitable weight before you buy or use any baby/child car seat or boosters.
- Make sure baby / child car seat or boosters are securely fitted.
- If unsure, get expert advice. Many retailers have trained in-store experts who can advise the best kind of baby / child car seat or boosters and show you how to fit it.
