### Every Child Matters Change For Children

### Minister Responds to Concerns on Childcare Registration Fees 20 Jun 2008

In response to comments from the childcare sector, increases in registration fees for child care providers are to be introduced gradually, and in small increments over the next three years, and a new system of fee banding introduced from September 2008.

Speaking at the National Day Nurseries Association conference in Salford, Children's Minister Beverley Hughes said: "We consulted on the childcare registration and inspection fees in 2006 and the majority of respondents supported our proposals that fees and subsidy arrangements should be changed to achieve a fairer balance between the fees providers can afford to pay and targeting money locally to those who need it.

It is our vision to ensure that every child gets the best start in life and to help parents choose with confidence how they balance work and family life. Good quality childcare is key to this."

Three fee bands will be introduced to allow greater flexibility that takes into account the length of time the provision is available and consequently the level of income.

Fee increases will be held to modest increments over the next three years to give

the sector greater reassurance and stability and to help providers to consolidate and build on the change of recent years.

The Government will set out nearer the time how it will review the level of fees after 2010.

## **DPUK MAILSHOT** Your experiences, your views, your topics....

IVF (In Vitro Fertilisation) – What are your views on House of Lords decision on rejecting deaf embryos in favour of hearing embryos?



Many women would be grateful to be offered IVF and I doubt they would question the techniques used. I personally do not feel being deaf is a bad thing or perceived as a disability, but that nature should take its course and allow the implanted embryo to develop into whatever God thought it should be male/female deaf/hearing.

I am a hearing mother to a Deaf child. What most people do not realise is that there is a whole Deaf culture out there, with its own language and lifestyle. Being Deaf is much more than not being able to hear and is unlike other "disabilities"

The truth is most deaf children are born to hearing parents, but naturally, those people who are living in the Deaf culture, would prefer to be raising Deaf children in that culture.

I personally don't have anything against IVF, and I don't think being deaf is wrong either. However, I would prefer they don't screen embryos at all, thus eliminating the debate entirely!

### Mum to a deaf child, Gloucestershire.

I'm a disabled woman myself with a genetic condition, which means I have a 50 per cent chance of having a child with my condition.

I am proud of my identity and I believe passionately in equal rights for disabled people. If I want to have IVF and conceive a child with or without my condition that should be my choice and not the government.

I certainly agree it should be a choice for parents to make, not a choice for the government. The option to screen embryos for disabilities should be exactly that, an option, not enforcement.

Do you have any concerns about your teenage social networking such as the use of Bebo, Facebook, Tagged and,

## the dangers and risks of their profiles being exploited?

I have a daughter who in many ways is a typical teenager – she has weight and self esteem issues and occasionally fell out with her peers. She is 14 years old and enjoyed using the 'social networking' websites such as MySpace, an innocent pursuit which has

resulted in her profile being exploited in an unnecessary manner.

She was feeling low one day when she logged online and was thrilled to be chatted up by a 16 year old boy and over the next few weeks they chatted, gossiped and exchanged

compliments like any other teenagers would do and this was a welcome lift in her spirits.



But then out of a blue, the same boy told her he didn't want to be friends with her anymore and to her horror, she learnt he had forwarded her secrets and confessions to a circle of friends and delivered a spiteful posting that sent her into a down spiral

#### depression.

As a mother, I regularly monitor her internet use and find this cyber bullying a commonplace – with millions of children having access to computers and mobile phones, the problems are reaching epidemic proportions!

Anonymous behind cyber bullying means

children can say things that are much more extreme and through manipulation of emails, social networking sites – bullying no longer stops at the school gates.

I have reported this claim to the police but the obvious problem is that the police tracking them down are time consuming – it's any wonder the bullies tend to get away scot free.

The vast quantity of information uploaded

means the service providers struggle to 'police' the contents. What is the government doing about it?

### **Profile:** Asif Igbal, DPUK Project Manager



Asif was well known his in previous job as Project а Manager for Parentline Plus for two years, representing 25 million parents. Asif explained:

"Here. Т was responsible in

developing and strengthening partnerships with agencies in statutory and voluntary sectors/stakeholders on national level, in working with the most excluded families.

I also managed the training & development including 'Training the Trainers' course that will enable parents to deliver the Parentline 'Parents Together' Plus's accredited & evidence-based family support services to families of excluded communities.

In my extensive role at Parentline Plus, I developed and manage four pilot projects from scratch on national level in partnership with organisations who works with excluded communities (i.e. Deaf Parenting UK, African Women Care Centre, Tamil Welfare Group, Refugee Council and Chinese Mental Health Association, Heartlands School, Birmingham), through the development, piloting and rolling out a franchising model of services which providing key opportunities and ensuring Trainers are recruited from the excluded communities who are parents themselves to provide the 'Parents Together' courses. This would in turn support parents from excluded communities with their parenting skills at home to increase their parental engagement with their children thus lead to their improved learning & social outcomes.

Together with my experiences from Parentline Plus, I am delighted to join Deaf Parenting Project Manager.



To date, I have succeeded in raising the profile of Deaf Parenting UK (DPUK) as a national voluntary organisation, small secured several high profile ambassadors to represent and celebrities/ politicians to support Deaf Parenting UK as a unique organisation for Deaf parents. I have also made contact with local, national and international Deaf organisations across the world, to share good working practices of providing information and support to Deaf parents.
