## MOJO MAKE HISTORY AS THE FIRST DEAF NEW ZEALAND MP



Mojo Mathers has become the first New Zealand Deaf MP after winning a special vote.

Green MP Mojo Mathers' election will raise the profile of deaf people and

issues, Deaf Aotearoa says.

Ms Mathers was yesterday confirmed as the Green Party's 14th MP - all of whom are list MPs - after special votes were counted.

She is profoundly deaf after being starved of oxygen at birth.

Deaf Aotearoa chief executive Rachel Noble said Ms Mathers was a great role model to the deaf community and commended the Green Party leadership for ensuring there were no barriers for Ms Mathers in her quest to become an MP.

"Through her previous policy work for various organisations, Mojo has been a great ambassador in demonstrating that deaf people can do anything," Ms Noble said.

"In this new, challenging role, she will be able to promote the issues, like easy access to sign language interpreters, that stand in the way of so many deaf people fully achieving their potential."

Other MPs would learn about deaf issues and the realities of life for deaf people simply by working alongside Ms Mathers, Ms Noble said.

Ms Mathers said she was looking forward to the first day of Parliament, on December 20, when she would become New Zealand's first deaf MP and only the fifth in the world.

## **Appointments of 2 New Ambassadors**

Deaf Parenting UK are delighted to welcome two new Ambassadors to represent our work.

#### **Dr. Joanna Downes**



Joanna's interest in issues parenting started when she commenced her doctorate research into deaf children and attachment. She met deaf parents who had with been faced negative attitudes from professionals

when they tried to access services for their children. This started her work in trying to raise and promote the awareness and needs of making mainstream services accessible to both deaf children and deaf adults.

Joanna has a strong interested in enabling deaf people to access mental health services and making sure that professionals do not use deaf parents' children as interpreters. This led to Joanna producing guidelines for the NHS to follow in both primary care on how to work with and book BSL interpreters.

In 2009, after Joanna completed her doctorate, she went onto become Manager of the Deaf parenting Programme at Action Deafness with funding from the Parenting Fund. This programme identified the many gaps in services and information for Deaf parents.

One gap was the awareness of midwives where deaf parents had repeatedly informed Joanna that they had received poor services. This led to collaboration with DeMontfort University in delivering the first

CPD course for midwives to understand in depth the psychological, social and mental health issues deaf parents and children may experience.

Joanna went on to win two awards at the first Deaf Parenting UK Awards event in October 2011 and the DeMontfort University also won an award for the course she wrote.

Joanna is now a freelance consultant and researcher, so she can spend more time with her two young children, who both communicate bilingually in English and BSL.

She says "It is excellent that there is an organisation aims to break down barriers for deaf parents because many deaf parents put up with sub-standard services and appalling attitudes. As an ambassador, I will try to promote awareness and remind professionals and the public of their duty to make sure Deaf parents get equal treatment, because it is their right."

#### Clive Boswell



Clive Boswell is currently employed as Auditor for the Foreign Commonwealth and Office. Clive was born deaf and has recently been fitted with cochlear implant. He is with married two children.

"I am truly honoured to have been asked to become an Ambassador for Deaf Parenting UK. I believe that being deaf (since birth and connexion 26) I face challenges and prejudice every day of my life. I hope this has resulted in my becoming more resilient for the remainder of my life! I also hope this experience will enable us to provide support/ knowledge/ wisdom and emotionally to our children; even though they are hearing; having deaf parents will no doubt give them challenges of their own.

I fully support the aims and objectives of Deaf Parenting UK and hope to be able to contribute positively."

# Victory for children as importance of a relationship with both parents is set to be recognized (3/2/2012)

Reports this morning in the press suggest that the Government will announce plans on Monday to introduce legislation ensuring children have the right to maintain an ongoing relationship with both parents following divorce and separation. This move would represent a tremendous step forward for family law, and benefit the thousands of children who lose contact with a loving parent unnecessarily each year.

Ken Sanderson, CEO of Families Need Fathers, commented, "A move to introduce legislation enshrining a child's rights to an ongoing meaningful



relationship with both parents would be a victory for children. For too long, we have seen children of many separating couples across the country lose out on the emotional and social benefits of a loving relationship with both parents following separation and divorce, and we are delighted that the government intends to address this situation. This is not a question of fathers' or mothers' rights; it is about protecting the rights of children to have two loving parents fully involved in their lives wherever possible, to the benefit of the children, their families, and wider society."

Government proposals on family law have the potential to dramatically improve outcomes for children in the UK (6/2/2012)

STATEMENT OF IMPORTANCE OF BOTH PARENTS IN LAW WILL COMPLEMENT THE WELFARE NEEDS OF CHILDREN; IMPROVEMENT OF ENFORCEMENT WILL INCREASE PUBLIC CONFIDENCE IN SYSTEM

Families Need Fathers welcomes the Government's response to the Family Justice Review. Although there is much work to be done to ensure that the family justice system provides better outcomes for children and families in practice, the Government's proposals mark a clear step forward for private family law in the UK.



Families Need Fathers agrees that disputes about parenting arrangements are best settled out of court, and supports the Government's proposals to increase the frequency and

strength of private family arrangements.

However, there will always be a sizeable minority of intractable cases where court becomes unavoidable, and it is in these cases that today's recommendations mark a positive development for the family justice system.

Key proposals include the intention to introduce a legislative statement on the importance of children having an ongoing relationship with both parents following separation wherever possible, and a desire to strengthen enforcement sanctions where court orders are breached.

Ken Sanderson, CEO of Families Need Fathers, commented, "The proposals announced today will help to improve public confidence in the family justice system. By reinforcing the law's commitment to ensure children benefit from the love and support of both parents following separation, the Government will help to ensure that it is not

children who continue to be punished when acrimony between separating parents is played out in the courts."

"This is not a question of equally dividing time, but of ensuring that children get to benefit from the full involvement of both parents following family breakdown. We support the Government's belief that developing legislation emphasizing the importance of both parents in a child's life is complimentary to the welfare needs of the child, and hope that this will be the beginning of a process of reform that will see the development of a family justice system fit for the needs of children and their families."

Other important proposals include the replacement of 'contact' and 'residence' orders, which encourage a 'winner takes all' mentality in private family law disputes, with 'child arrangements orders', which are more child focused. However, the decision to continue requiring grandparents to apply for permission before they can make an application to court to see their grandchildren indicates that there is still work to be done to ensure that the rights of children to a relationship with their wider family are adequately protected.

## GOVERNMENT PROTECTS FUNDING FOR SEN SPECIALIST SUPPORT SERVICES (3/2/2012)

The Department for Education has today confirmed that local authorities will not lose funding for specialist SEN support services in 2012/13 as a result of the academies programme.

This news means that councils should provide services to deaf children in academies free of charge, as for all other maintained schools.

As academies are independent of local authorities, there have been longstanding concerns that the academies programme would drain funding from vital local authority specialist support services for deaf children.

with Working the Special Educational Consortium. **NDCS** lobbied has Government since 2010 on this issue, and supported a successful amendment to the Academies Act 2010 to protect deaf children's services. Recognising these concerns and the impact that delegation of funding can have on services to meet low incidence needs, such as deaf children, the Department has now committed to ensuring that deaf children are not disadvantaged by funding reforms.

Given that the Department for Education has also protected the schools budget, from which these services are funded, NDCS will be demanding that local authorities protect funding for specialist support services for deaf children and robustly challenging any proposed cuts in 2012/13.

# ENABLING COMMUNICATION IS VITAL IN FAMILIES OF DEAF CHILDREN

Families need to learn to sign for the sake of their deaf children – yet they are often denied the chance.

In the last few weeks, a video of a deaf mother and her two year-old daughter Ava having a dinner conversation in British Sign Language (BSL) has gone viral. It has been tweeted, shared and blogged to the extent that the clip now has more than 150,000 views online. The video shows the level of understanding and communication that a child using sign language can reach when they have access to language from an early age.

Ava's parents are deaf, so they knew how to sign with her.

However, 90% of deaf children are born to hearing parents, and at the moment, it is incredibly difficult for them to access courses so they can learn to sign. A National Deaf Children's Society (NDCS) telephone survey last summer found that 56% of councils did not provide any services or support for parents of deaf children wanting to learn sign language, and the councils that do often require parents to pay for the course – which can cost up to £600.

Gary Morgan, professor of psychology at City University, London, told me that a delay in access to language and communication "can have severe and long lasting effects for a child's cognitive, social-emotional and academic skills. Many deaf children arrive at school with the task of learning a first language rather than learning about the world through already developed language."

Anna Lewis, from Dorset, is learning BSL in order to be able to communicate with her three year-old daughter, Belle, who is profoundly deaf. She told me: "communication with Belle is difficult. Due to her late diagnosis she had two and a half years of a silent, un signing world. We use a mixture of BSL, speech and pictures with her. Everv day is а struggle communicate."

When Belle was diagnosed as being deaf, their council provided only an introductory course in signing communication. No further support was offered so now, at their own cost, Anna is taking a BSL level one course, travelling 30 miles every week for a two-hour class. The cost of the course is £200 and the family could not afford to pay for her husband to join her.

She said: "We just can't afford for us to both do it and pay for the childcare. My husband feels like he is being denied his fundamental right of being able to communicate with his child. It is disappointing and just plain wrong that we are penalised for Belle being deaf."

There is a huge irony here, in that signing classes for non-deaf children have become hugely popular. Just before Christmas, my three-year old daughter's pre-school was visited by Singing Hands, who perform children's songs using signs. I was amazed at how many children knew how to sign along with them, and it struck me that just as hearing parents across the country struggle to learn to sign with their deaf child, thousands of non-deaf children are benefiting from being exposed to sign language from a young age.

To try and give parents of deaf children everywhere access to a course that gives them the signing skills they need, NDCS has developed a family sign language course, which is specifically aimed at families of deaf children who want to use BSL. It teaches the signs and phrases needed for nursery rhymes, stories, games, as well as tools for practical communication (on topics such as food, sleeping and nappy changing, for example).

After piloting the course in two regions in July 2011, 83% of the 123 families who took part reported that they felt confident communicating with their deaf child, compared to 37% prior to the course. At the end of this month, the charity will submit a proposal that the DfE rolls out the course to all nine regions in the UK. The charity have launched a petition for fair access to the courses which now has over 2000 signatures.

At a time of deep cuts to services everywhere, it is hard to gain extra funding – but nothing could be more important than a deaf child being able to start to build their communication and understanding skills as early as possible. As the video of Ava shows, deaf children are capable of everything a hearing child is capable of, if they are just given the chance.

Deafax calls on schools and medical service providers to give deaf people Education & Advice on Relationships & Sex (E.A.R.S).

Deafax are launching a campaign on 28th March 2012 to call on schools, teachers and medical service providers to supply adequate sex education and sexual health care for deaf people.

Research into deafness and sexual health is extremely rare and almost completely overlooked. Deafax are pioneers in this area, carrying out in depth research within the deaf community and uncovering shocking results.

Out of a sample of profoundly and prelingually deaf mothers, 87% of which were British Sign Language users, only 17% received sex education in a 'deaffriendly' way at school with 33% gaining information from friends and family and another 33% with no information at all. The remaining 17% received non deaf-friendly sex education at school. 1/3 of young women interviewed were under influence of drugs or alcohol at the time of conception and many were unaware of walk-in clinics or heard of bad experiences when staff couldn't understand the deaf person.

Medical service providers mistakenly assume that written material (leaflets, booklets, websites) are suitable to relay health information to the deaf community.

On 1st October 2010, the Equality Act stated that it is a legal requirement for all service providers to make provision for the needs of deaf and hard of hearing people.

Yet research reveals that deaf mothers-tobe are generally unable to access antenatal classes and their midwives are not 'deaf aware' or trained on the best ways to communicate with a deaf person. Information on maternity leave and benefits entitled to them are not passed on and deaf mothers say they feel isolated and have no communication with health visitors.

Out of all the health trusts Deafax spoke to, just one had a midwife who could sign, she had funded her own training.

100% of those who took part in the study believed that the level of service is not the same for both deaf and hearing expectant mothers.

In response, Deafax are launching a Sexual Health Package, tailored for deaf students and teachers to deliver invaluable information on safe sex and STIs to deaf students, using communication methods to suit individual needs.

Deafax have also developed training packages for teachers of the deaf in the field of sex education and deaf awareness workshops for mainstream organisations. They are asking all those in the deaf community to contribute to this under-researched area by completing this survey – so that service providers and schools can no longer overlook the needs of deaf people.
